**COMMENTS OF THE JOINT SPORTS CLAIMANTS**

The Office of the Commissioner of Baseball, the National Basketball Association, the National Football League, the National Collegiate Athletic Association, the National Hockey League and the Women’s National Basketball Association (collectively the “Joint Sports Claimants” or “JSC”) submit the following response to the Notice published at 79 Fed. Reg. 59306–59307 (Oct. 1, 2014) (“Notice”). The Notice seeks comments related to the Motion of Phase I Claimants for Partial Distribution (filed July 25, 2014), which requests the Copyright Royalty Judges (a) to distribute 60% of the 2012 satellite royalties to the Phase I Parties, including JSC; and (b) to distribute those funds in bulk to a common agent (the Office of the Commissioner of Baseball). The Notice also seeks comment on the “existence and extent” of any Phase I and II controversies involving the 2012 satellite royalty funds. *See* Notice at 59307.

The status of Phase I controversies is addressed in the Comments of Phase I Parties filed on October 31, 2014. With respect to the existence of Phase II controversies in the sports category, JSC represents that there are no controversies among or between JSC and any of its individual members.
