**JOINT PETITION TO PARTICIPATE OF THE
NATIONAL ASSOCIATION OF BROADCASTERS**

The National Association of Broadcasters (“NAB”) files this petition to participate in the above-referenced proceeding in response to the Notice issued by the Copyright Royalty Judges on April 2, 2008.¹ The Notice announces the commencement of a proceeding to determine the Phase I distribution of the 2000, 2001, 2002, and 2003 royalties collected under the cable statutory license, and consolidates these years into a single proceeding.

NAB will participate in the proceedings on behalf of all U.S. commercial television broadcast stations retransmitted by cable operators as distant signals during 2000, 2001, 2002, and 2003. NAB has served as the sole representative of the Commercial Television category in every Phase I cable royalty distribution proceeding since the 1979 proceeding,² and is aware of no objection to its continuing representation of the interests of this Phase I claimant category.

² In the first cable royalty distribution proceeding, covering retransmissions occurring in 1978, the Copyright Royalty Tribunal made a single Phase I award to all commercial television broadcasters, which were represented by NAB as well as by certain Canadian broadcast companies. 1978 Cable Royalty Distribution Determination, 45 Fed. Reg. 63026, 63042 (Sept. 23, 1980). The Commercial Television category in subsequent proceedings covered works owned by U.S. commercial television stations only.

NAB is a party to the Phase I settlement agreement that has previously been reported to the Copyright Royalty Judges. *See Phase I Claimants' Notice of Partial Phase I Settlement and Motion for Further Distribution*, Docket No. 2005-4 CRB CD 2003 (June 8, 2007); *Phase I Claimants' Notice of Partial Settlement and Motion for Further Distribution*, Docket Nos. 2002-8 CARP CD 2000; 2003-2 CARP CD 2001; 2004-5 CARP CD 2002 (December 6, 2005). The Phase I Commercial Television share for 2000-2003 has been resolved as a result of this settlement, subject to the resolution of the sole remaining Phase I issue in this proceeding, the percentage share to be awarded to the Canadian Claimants category.

In accordance with 37 C.F.R. § 351.1(b)(2)(ii)(B),³ NAB attaches lists identifying participants in this Joint Petition by respective year. The undersigned certifies, on information and belief, that, as of the date of submission of this Joint Petition, the undersigned has the authority to represent all U.S. commercial television broadcasters, including the authority and consent of the listed participants, with respect to the Phase I Commercial Television category in this consolidated cable royalty distribution proceeding. These participants have a significant interest in the subject matter of the proceedings because the stations they represent own programming retransmitted by cable systems for which they are entitled to receive cable royalties for the relevant years.

NAB respectfully reserves its right to modify the attached lists in response to rulings of the Copyright Office or the Copyright Royalty Judges, the acquisition of additional evidence, or the filings of additional claimant parties.

³ For reasons stated in the Comments of Copyright Owners on the Copyright Royalty Board Regulations that were filed in Docket No. RM 2005-1 on July 1, 2005, and November 13, 2006, respectively, NAB believes that it is unduly burdensome and should be unnecessary to specify all of the individual claimants encompassed within a Phase I category in a cable royalty distribution proceeding. NAB intends to request an appropriate amendment of the Rule at a future time.
