JOINT PETITION TO PARTICIPATE

Pursuant to 17 U.S.C. §§801(b)(3) and 804(b)(8) and 37 CFR §351.1(b)(2), certain Devotional Claimants, as listed below (“Joint Petitioners”) hereby submit their Joint Petition to Participate in the proceeding of the Copyright Royalty Judges to determine the Phase I and Phase II distribution of the 2010-2012 royalties collected under the satellite statutory licenses. This Joint Petition is submitted in response to the Copyright Royalty Judges’ (“Judges”) notice published at 79 Fed. Reg. 76396 (December 22, 2014) (“Notice”). A \$150 filing fee accompanies this filing.


