**SPANISH LANGUAGE PRODUCERS  
PETITION TO PARTICIPATE IN DISTRIBUTION PROCEEDINGS**

Spanish Language Producers (“SLP”), pursuant to the *Notice Announcing Commencement of Distribution Proceedings With Request for Petitions to Participate*, published December 22, 2014 by the Copyright Royalty Board, Library of Congress, 79 Fed. Reg. 76396, hereby notifies the Copyright Office as follows:

SLP maintains claims in the yet-to-be-established Spanish language programming category. SLP asserts that a controversy exists with respect to the 2010-2012 satellite royalty funds in Phase I (and Phase II if a new category is established) with regard to programming initially owned or controlled by those parties identified on the attached Exhibit A.

SLP notifies the Copyright Office of its intent to participate in any Phase I proceedings in connection with its representation of claimants with Spanish language programming claims, and to the extent that such proceedings address the appropriate definition of Phase I program categories. SLP intends to participate in any Phase II proceeding involving Spanish language programming, if any qualifying claimants come forward. It files this as a Joint Notice on behalf of itself and all the parties listed in the attachment hereto.


SLP reserves the right to amend its list of represented participants as such amendments may be necessary and legally permissible. As of the date of the Petition to Participate, SLP and its undersigned counsel certify that they have the authority and consent of each of the parties listed on the attachment to represent them in the 2010-2012 satellite distribution proceedings. As the copyright owners and holders of programming broadcast on stations whose signals were carried on a distant signal basis during any time

2010 through 2012, SLP and the parties listed on the attachment have a significant interest in the subject matter of these proceedings.

As required by the Judge's notice, SLP has attached a check with their \$150 filing fee, payable to the Copyright Royalty Board.
