COMMENTS OF NATIONAL PUBLIC RADIO, INC.

National Public Radio, Inc. ("NPR") submits the following comments in response to the Federal Register notice, dated December 22, 2014, 79 Fed. Reg. 76396, soliciting comment on the existence of any controversies with respect to the distribution of the 2013 cable and satellite royalty funds. NPR has traditionally represented and received a Phase I share of cable royalty funds for itself and participating NPR Member station licensees, and it timely filed a joint claim to the 2013 cable royalty funds. NPR historically has not filed a claim for satellite royalty funds, and it did not file a claim for satellite royalty funds for 2013.

With respect to Phase I of the 2013 cable royalty funds as of this date, the shares of funds to be allocated to NPR and the other Phase I claimant group representatives remains in controversy. With respect to Phase II, NPR is unaware of any Phase II claims to the share of the 2013 cable royalties to be awarded to NPR and its participating member station licensees. At the

same time, there is also no Phase II settlement to report at this time.
