**MULTIGROUP CLAIMANTS’
PETITION TO PARTICIPATE IN DISTRIBUTION PROCEEDINGS**

Multigroup Claimants (MC), pursuant to the *Notice Announcing Commencement of Distribution Proceedings With Request for Petitions to Participate*, published June 5, 2015 by the Copyright Royalty Board, Library of Congress, 80 Fed. Reg. 32182, hereby notifies the Copyright Office as follows:

MC maintains claims in the syndicated programming, sports programming, and devotional programming categories. MC asserts that a controversy exists with respect to the 2013 satellite royalty funds in Phase I and Phase II of the these categories with regard to programming initially owned or controlled by those parties identified on the attached Exhibit A.

MC notifies the Copyright Office of its intent to participate in any Phase I proceedings in connection with its representation of claimants with devotional programming claims, and to the extent that such proceedings address the appropriate definition of Phase I program categories. MC intends to participate in any Phase II proceeding involving syndicated programming, sports programming, and devotional programming categories. It files this as a Joint Notice on behalf of itself and all the parties listed in the attachment hereto.


MC reserves the right to amend its list of represented participants as such amendments may be necessary and legally permissible. As of the date of the Petition to Participate, MC and its undersigned counsel certify that they have the authority and consent of each of the parties listed on the attachment to represent them in the 2013 satellite distribution proceedings. For purposes of clarification, certain of the parties

assigned rights to MC, or made independent claims, for less than the aggregate of 2013 calendar year. As the copyright owners and holders of programming broadcast on stations whose signals were carried on a distant signal basis during any time during 2013, MC and the parties listed on the attachment have a significant interest in the subject matter of these proceedings.

As required by the Judge's notice, MC has attached a check with their \$150 filing fee, payable to the Copyright Royalty Board.
