**PETITION TO PARTICIPATE**

SoundExchange, Inc. ("SoundExchange"), a nonprofit organization incorporated in the State of Delaware and jointly controlled by representatives of sound recording copyright owners and performers through an 18-member board of directors, on behalf of itself and the copyright owners and artists on whose behalf it collects and distributes statutory royalties, submits this Petition to Participate in response to the Copyright Royalty Judges' Notice announcing commencement of proceeding with request for Petitions to Participate in a "proceeding to adjust the rates and terms for the digital public performance of sound recordings by means of an eligible nonsubscription transmission or a transmission made by a new subscription service under section 114(f)(2) and for the making of ephemeral copies in furtherance of these digital public performances under section 112(e)," published at 70 Fed. Reg. 7970 (February 16, 2005).

The Librarian of Congress has previously designated SoundExchange as the sole entity to receive royalty fees and statements of account submitted by services purporting<sup>1</sup>

<sup>1</sup> It has come to SoundExchange's attention that some services that have filed with the Copyright Office a Notice of Use of Sound Recordings under Statutory License may be under the misimpression that by accepting payment from them, SoundExchange has acknowledged that they comply with the requirements

to operate as eligible nonsubscription transmission services and new subscription services under provisions of the Section 112 and 114 licenses that are directly at issue in the above-referenced proceeding. See 37 C.F.R. § 262.4(b). In this capacity, SoundExchange represents not only the interests of those sound recording copyright owners<sup>2</sup> and featured performers who have specifically authorized SoundExchange to collect and distribute royalties on their behalf, but also those unaffiliated sound recording copyright owners and featured performers who are entitled to a portion of the royalties paid by services claiming the benefits of the statutory licenses.

The sound recording copyright owners who have specifically authorized SoundExchange to act as their agent for the collection and distribution of statutory royalties own the copyrights in approximately 85% of all legitimate sound recordings legitimately sold annually in the United States. SoundExchange also has been designated as the agent for approximately one thousand featured recording artists entitled to statutory royalties. Accordingly, SoundExchange, on its own behalf and as an agent for sound recording copyright owners and featured performers, has a significant interest in the royalty rates and terms that are the subject of the instant proceeding. See 17 U.S.C. § 803(b)(1)(B). Attached as Exhibit A is a list of SoundExchange's sound recording copyright owner members. Attached as Exhibit B is a list of SoundExchange's featured

of the statutory licenses under Sections 112 and 114 of the Copyright Act. It is the responsibility of each such service to ensure that it is in full compliance with the requirements of the statutory licenses under Sections 112 and 114 of the Copyright Act. SoundExchange is not in a position to, and does not, make determinations as to whether each of the many services that rely on the statutory licenses is eligible for statutory licensing, nor does it continuously verify that such services are in full compliance with all applicable requirements. Accordingly, SoundExchange's acceptance of a service's payment does not express or imply any acknowledgment that a service is in compliance with the requirements of the statutory licenses. SoundExchange, its members and other copyright owners reserve all their rights to take enforcement action against a service that is not in compliance with those requirements.

<sup>2</sup> The sound recording copyright owners who authorize SoundExchange to represent their interests do so on a non-exclusive basis. Each sound recording copyright owner retains the right to license directly any copyrighted sound recordings they own or control.

performer members. These lists may be amended as additional sound recording copyright owners and featured performers authorize SoundExchange to represent their interests.

On behalf of those members who have specifically authorized SoundExchange to act on their behalf, SoundExchange intends to engage in negotiations with many of the eligible nonsubscription transmission services and new subscription services that operate under the Section 112 and Section 114 statutory licenses, and remains hopeful that voluntary settlements establishing rates and terms for all similarly situated statutory licensees will be reached and that arbitration proceedings will be avoided. If arbitration proceedings are required to establish rates and terms for the Section 112 and Section 114 statutory licenses for some or all of the services involved in the above-captioned proceeding for the period January 1, 2006 through December 31, 2010, however, then SoundExchange will participate fully in any such proceedings.
