
**PETITION TO PARTICIPATE
OF THE PUBLIC TELEVISION CLAIMANTS**

Pursuant to the notice issued by the Copyright Royalty Judges and published at 75 Fed. Reg. 455 (Jan. 5, 2010), the Public Broadcasting Service (“PBS”) hereby provides notice of its intent to participate in the proceeding for the adjustment of cable statutory license royalty rates on behalf of public television stations and the copyright owners of programs broadcast by public television stations that are retransmitted by cable systems pursuant to the Section 111 compulsory license (the “Public Television Claimants”). A \$150 filing fee accompanies this filing.

PBS and the Public Television Claimants have a significant interest in the subject matter of this proceeding because they have participated in distribution proceedings for the past several decades and have received a share of the cable compulsory license royalty funds for each year that the funds have been distributed. PBS and the Public Television Claimants expect to own programming that likely will be retransmitted in future years by cable systems, for which they will be entitled to receive cable royalties paid in accordance with any cable rate adjustment that may be adopted in this proceeding.

PBS has served as the sole representative of the Public Television Claimants in cable royalty distribution proceedings and various rate proceedings for the past thirty years, and is aware of no objection to its continuing representation of their interests in this rate proceeding. The undersigned hereby certify, on information and belief, that, as of the date of submission of this Petition to Participate, they have the authority and consent to represent PBS in this proceeding on behalf of the interests of the Public Television Claimants, including the participants currently receiving cable royalty distribution through PBS, which are named in the attached list. PBS respectfully reserves its right to modify the attached list in response to rulings of the Copyright Office or the Copyright Royalty Judges, the acquisition of additional evidence, or the filings of additional parties.
