**AMENDED JOINT PETITION OF THE BROADCASTER CLAIMANTS GROUP  
TO PARTICIPATE IN PHASE II SATELLITE ROYALTY PROCEEDINGS  
REGARDING SYNDICATED DEVOTIONAL AND  
PROGRAM SUPPLIER ROYALTIES**


The Broadcaster Claimants Group (“BCG”) files this petition to participate in the above-referenced proceeding in response to the Notice issued by the Copyright Royalty Judges on August 16, 2013. 78 Fed. Reg. 50114 (August 16, 2013). The Notice announces the commencement of a proceeding to determine the Phase II distribution of the 1999, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, and 2009 royalties collected under the statutory license, and consolidates these years into a single proceeding.

BCG will participate in the proceedings on behalf of a group of broadcaster claimants that are entitled to receive shares of the Devotional or Program Supplier royalties. In accordance with 37 C.F.R. § 351.1(b)(2)(ii)(B), BCG attaches a list identifying participants in this Joint Petition. Exhibit 1 identifies claimants with claims to royalties in the Program Supplier category. Exhibit 2 identifies claimants with claims to royalties in the Devotional category. These participants have a significant interest in the subject matter of the proceedings because they have claims to royalties for syndicated programs that were retransmitted on distant signals by satellite carriers during the relevant years.

The undersigned certifies that the undersigned has as of the date of submission of this Amended Joint Petition, and did have as of September 16, 2013, the authority and consent of the claimants identified in Exhibits 1 and 2 to represent them with respect to the Phase II Devotional and Program Supplier categories in this consolidated satellite royalty distribution proceeding. BCG respectfully reserves its right to modify the attached list, withdraw Phase II claims, or make additional Phase II claims in response to rulings of the Copyright Office or the Copyright Royalty Judges, the acquisition of additional evidence, or the filings of additional claimant parties.
